We would like to increase the number of student-teachers for Spring 2019 to at least 4 using recruiting from within, transfer students, and the newly formed post-baccalaureate program.

Our goal is to be more conservative this year and recruit two new Mathematics Education students.

10. Describe your goal.

Our short-term goal will be to recruit 4 new mathematics education students next year. Our long-term goal is to get to at least 10 student-teachers per spring semester, through the M.A.T. program and the B.S. Mathematics 7–12 program. This will be done using various outreach projects including the newly formed Math Circle, funded by the Dolciani Grant, where we will work with middle school students and teachers on interesting mathematics projects one Saturday per month. Recruiting high school students will be done using the MaPP competition, where students come for a one-day scavenger hunt solving mathematical puzzles along the way. We hope to see results from these outreach activities in 3 – 5 years. One way to help us reach our goal is to revise the mathematics major degree requirements, possibly removing the B.S. All programs prepare our candidates to integrate technology effectively into curricula and instruction. This is infused in curriculum throughout the candidates program. Some programs instruct candidates to review software that is available by discipline to enhance instruction. Most programs instruct candidates to utilize technology to effectively collect, manage and analyze student data. This is infused into programs through a variety of ways. In some programs, mini tab statistical analysis is used, in others excel spreadsheets and graphing are utilized to demonstrate the results of pre and post testing. Universal Design for learning is infused throughout some of the programs. This concept promotes the idea of designing all lessons/learning experiences right from the beginning to be accessible to the broadest range of learners. Candidates are taught to provide multiple means of representation (to present all information in a variety of formats/media), to provide multiple means of expression (all students to demonstrate knowledge in a variety of ways, not just through writing), and to provide multiple means of engagement (design learning opportunities to engage learners such as working with partners or small groups as well as letting students select the type of material from which they want to learn specific information). Candidates in several programs also learn to consider a broader definition of 21st century literacy and are required to design instruction that integrates multiple forms of media and alternate forms of expression (in addition to traditional print text). Technology integration in the classroom, managing and analyzing data and improving teaching for the purpose of the principles of UDL will be a large focus in the next academic year.

All candidates take one of the following courses depending on their program, SED 225 – Introduction to Exceptionalities, SED 481 – Teaching Exceptional Students in the Elementary Classroom, SED 482 – Teaching Exceptional Students in the Secondary Classroom, or SED 502 – Introduction to Exceptional Students. Each of these courses focuses on addressing the legal, educational, and instructional needs of all students with exceptionalities. Our candidates are prepared to design instructional activities to meet identified needs, and modify instruction so students can participate successfully in the least restrictive environment.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

All certification candidates get the opportunity to participate as a member of individualized education program teams as an activity in one of the courses listed above.

c. Effectively teach students who are limited English proficient.

All certification candidates take either EDU 471 – Supporting English Learners or the graduate-level equivalent EDU 571 – Teaching ELLs in the Regular Ed Classroom to ensure they are able to meet the needs of students who have limited English proficiency.

a. Teach students with disabilities effectively

All certification candidates take one of the following courses SED 225 - Introduction to Exceptionalities, SED 481 - Teaching Exceptional Students in the Elementary Classroom or SED 482 - Teaching Exceptional Students in the Secondary Classroom. Each of these courses focuses on addressing the legal, educational, and instructional needs of all students with exceptionalities. Our candidates are prepared to design instructional activities to meet identified needs, and modify instruction so students can participate successfully in the least restrictive environment. All of the following courses have clinical field experience components: SED 435 Language Arts for Exceptional Individuals and lesson planning, SED 365 Basic Principles of Academic Assessment and Remediation for Exceptional Individuals, and SED 449 School Based Experience in Special Education. In addition, there are 5 additional Special Education courses that in addition to preparing candidates to gain the content knowledge necessary to address the needs of students with special needs also include clinical field experience to augment the courses.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Our students are also required to take SED 325 which focuses on developing goals and objectives for participating in IEP meetings. In order to best prepare candidates to effectively participate as a member of the students' IEP teams, candidates take SED 445 - Collaboration in the Schools. This course prepares candidates to work collaboratively with teachers, support specialists, paraprofessionals, and parents.

c. Effectively teach students who are limited English proficient.

All candidates also take EDU 471- English Language Learner to ensure they are able to meet the needs of students who have limited English proficiency. To complement the coursework, several of the courses candidates enroll in have clinical fieldwork.
